ORDER

Sub:- Wide publicity of various schemes launched by Ajmer Discom to recover outstanding dues and to provide domestic connection.

In recent past various schemes have been launched by Ajmer Discom to recover outstanding dues from consumer, disposal of pending VCR's and to provide maximum domestic connections to households in Rural areas. To make aware the consumers/ households regarding various schemes, **Executive Engineer (O&V) are directed to organize Sarpanch Sammelan** in their respective area. They will ensure participation of concerned Assistant Engineer, Junior Engineer and Feeder Incharge in the Sammelan and making the sammelan successful.

The details of various schemes and action to be taken for publicity of schemes is as under:-

1. Amnesty Scheme (effective upto 31.10.2017) : An amnesty scheme to recover outstanding dues of Domestic and non domestic category, being disconnected from 01.04.2007 to 31.03.2016 is in force upto 31.10.2017 (Comml. AJ – 670, 681& 692). The Executive Engineer (O&V) will provide feeder wise list of such consumers along with details of their outstanding dues and the amount to be deposited after availing benefit of the schemes to the feeder incharge, who will personally contact all consumers and apprise about the scheme so that maximum people can avail benefits of the scheme.
2. Disposal of pending VCR's (effective upto 30.11.2017) : The Assistant Engineer (O&M) are authorized for disposal of VCR's pending upto June, 2016 vide Comml. AJ - 686. The Executive Engineer (O&V) will sort out the feeder wise list of pending VCR's and provide them to respective feeder incharge, so that they can inform about the scheme to the concerned consumers/ non consumers for availing benefits of the scheme. The information in this regard shall regularly be sent on monthly basis by the Executive Engineer (O&V) to concerned Superintending Engineer (O&M)


and Superintending Engineer (Vig.) in the format circulated through Comml. AJ - 686.

3. **Release of Domestic Connections to Rural Households (Comml. AJ - 669):** Domestic connections to rural scattered households shall be provided in a group of minimum 3 applicants in 100 meter radius from the single phase distribution transformer by recovering Rs. 3500/- from the each applicant. The single phase distribution transformer of capacity 5 KVA or more may be installed at load centre for this purpose by erecting single phase 11 KV line. The cost of line and transformer shall be booked under sanctioned DDUGJY scheme of the District upto the sanctioned financial limit of the District.

ZCE/SE shall ensure successful originizing of "Sarpanch Sammelan" at division level and will attend personally one such sarpanch sammelan in their jurisdiction. They will also ensure participation of concerned officers/ officials in the "Sarpanch Sammelan" and to send progress of various activities on monthly basis to SE (Plan), Ajmer Discom.

All concerned are directed for strict compliance of above directions.
