Sub: "Amnesty Scheme" for realization of outstandings
from Municipalities, Local Bodies & Govt. Deptts.

With a view to realize outstanding dues from Local Bodies & Govt
Departments, it has been decided to allow the following concessional
package. This facility would be applicab'e from 25th August to 30th
September'2001:

BRIEF DESCRIPTION	CONCESSION ALLOWED
Clearance of outstanding dues as on 31-3-2001	
(i) If the consumer deposits (lumpsum) the total outstanding dues on or before 30-9-2001.	Entire LPS/interest shall be waived off and only principal amount of outstanding dues shall be recovered.
(ii) Cases where the consumer is unable to make payment of total outstanding dues in lumpsum and CMD has permitted to deposit the outstanding dues in three equal monthly installments on merit of the case. However, in such cases also first installment should be deposited on or before 30-9-2001 to avail the benefit of scheme.	--do--

Terms & Conditions:


- i) The Scheme shall remain in force for a period from 25-8-2001 to 30-9-01.
- ii) The Scheme shall be applicable irrespective of whether the disconnected consumer wants reconnection or not.
- iii) To avail these concessions, the consumer shall voluntarily undertake to withdraw all the Court cases, if any, pending in any Court of law/Consumer Forum/MRTP Commission etc related to the outstanding dues.
- iv) After depositing the first installment, if the consumer fails to deposit the balance installments as per agreed time schedule under this concessional package, this facility shall be withdrawn for the balance outstanding amount.
- v) This concessional package will not be applicable for the amount of assessment made against theft of electricity or malpractice.
- vi) For availing this concessional package, the consumer shall be required to apply on plain paper to the concerned Asstt. Engineer.
- vii) The outstanding dues should be worked out without taking into consideration the adjustment of existing security deposit. However, adjustment of security deposit may be made for disconnected consumers on the dues so worked out as on date of disconnection. From such consumers, revised security deposit shall be obtained as per rules before reconnection, if any.
