### CIRCULAR

#### **Sub:-Extension of period of various schemes.**

Presently various concessional schemes are running in Ajmer Discom for welfare of consumers which are available upto 31.08.2018:

#### **i) Disposal of pending VCRs:**

For logical conclusion of pending VCR's of theft/ misuse nature, the scheme was introduced vide Comml AJ 686 dated 11.08.2017 and extended/modified from time to time. Presently this scheme is effective upto 31.08.2018 as per Comml AJ 757 dated 03.08.2018. This scheme is further extended to **30.09.2018** with the conditions that this Scheme now shall be applicable for the pending VCR's upto 31.03.2018. The other terms & conditions as prescribed in Comml AJ 743dt 27.04.2018 will remain same.

#### **ii) Amnesty Scheme:**

The Amnesty Scheme was made available for Non-domestic, Industrial ( except SIP rural) and mixed load category consumers disconnected upto 31.03.2017 and for regular/ disconnected consumer (irrespective of the date of disconnection) of domestic, agriculture, SIP (Rural) category and Central & State Govt. Department Connections (any category) vide order No. Comml AJ 739 dated 04.04.2018. The scheme was extended from time to time. Presently this scheme is effective upto 31.08.2018 as per Comml AJ 757 dated 03.08.2018. This scheme is further extended to **30.09.2018** with the same terms & conditions as prescribed in Comml. AJ 739 dt 04.04.2018.

#### **iii) Disposal of pending VCRs and Voluntary load disclosure scheme for Agriculture consumers:**

For disposal of pending VCRs of agriculture consumers and voluntary load disclosure and checking of agriculture consumers, scheme was introduced vide order No. Comml AJ 730 dated 13.03.2018 The scheme was extended from time to time. Presently this scheme is effective upto 31.08.2018 as per Comml AJ 757 dated 03.08.2018. This scheme is further extended to **30.09.2018** with the same terms & conditions as prescribed in Comml. AJ 730 dt 13.03.2018.
