ORDER

Sub: - Recovery of Fuel Surcharge amount for Second Quarter of FY 2019-20.


In exercise of powers conferred under clause 88 of the RERC (Terms & conditions for Determination of Tariff), Regulation, 2019, the Ajmer Discom hereby prescribes application of Fuel Surcharge at the rate of Rs. 0.27 per unit (KWh) for the 2nd quarter (July, 2019 to September, 2019) of the Financial Year 2019-20, recoverable on the consumption of previous quarter, for all categories of consumers. This fuel surcharge amount shall be recovered in three (3) monthly/bimonthly installments (as per billing cycles) from the consumers.

The above rate has been decided in terms of the order "Tariff for Supply of Electricity – 2018-19" and shall be over and above the rate of charge(s) prescribed in the said tariff order.

The CAO (ERB), Ajmer Discom will work out the amount of fuel surcharge in respect of subsidized category of consumers for claiming subsidy from Government of Rajasthan in order to keep effective charging from such consumers unchanged.
