Every year around 4-5 families are provided the financial support of Rs. 4 Lakh each. During FY 2020-2021, total Rs. 24 Lakh and in April'2021 Rs. 4 Lakh has been disbursed including 4 cases of Covid. As we all know a worse situation has arised and around 10-12 Samiti Members have lost their life in last 2 months due to second wave of this pandemic.

RSEB EBF Society has corpus fund of Rs. 1.50 Crores which yields approx. Rs. 7-8 Lakh interest per annum. Around Rs. 6-8 Lakh is received every year from new membership and monthly contribution.


In this difficult scenario, to swipe the tears of the families of our deceased fellow members, RSEB EBF Society needs an additional fund of around Rs. 30-35 Lakh.

All the members of the RSEB EBF society are requested to deposit an additional fund to *Samiti* for the humanity & brotherhood. The amount shall be as under and deducted from Salary in 5 installments.
