**Sub:- Grant of Dearness Relief to Pensioners of
AVVNL.**

In exercise of the powers conferred vide order No. AVVNL / CAO / Rules / F. 1 (13) / D. 505 dated 03.11.2001, the Managing Director, AVVNL, Ajmer has been pleased to adopt the State Government's order No. F. 15 (1) FD (Rules) / 98 dated 14.10.2004 (Copy enclosed) regarding grant of Dearness Relief to State Govt. Pensioners, for application in respect of Pensioners of AVVNL from 61% to 64% w.e.f. 1.07.2004.


Out of 61% Dearness Relief sanctioned vide order No. AVVNL / CAO / Rules / F & R / F. 1(3 / 4) / D. 900 Ajmer dated 21.06.2004 50% Dearness Relief has been treated as Dearness Pension and rest 11% Dearness Relief is to be allowed on pension / Family pension as per this office order No. AVVNL / CAO / F & R / F. 4 / D. 1134 Ajmer dated 14.07.2004. In case of employees retired / retiring on or after 1.7.2004, 11% Dearness Relief is to be calculated on the basis of two third of Basic Pension as per example given in Para 3 of Government of Rajasthan's order No. F. 13 (2) FD / Rules / 2004 dated 25.09.2004 (Copy enclosed).

Dearness Relief @ 3% shall be allowed w.e.f. 1.7.2004, on the total of Pension / Family pension and Dearness Pension.

The amount of Dearness Relief from 1.7.2004 to 30.11.2004 (5 months) shall be paid with Pension for the month of April-2005 payable on 1.5.2005.

The amount of Dearness Relief at increased rates for the month of December-2004 and onwards shall be paid alongwith Pension for respective month.


