**Sub:- Recruitment to the post of JEN, Accounts Officer,  
Junior Accountant and Helper.**

In reference to the approval of the State Govt. conveyed via letter No. F. 12 (4) Energy / 2003 dated 14<sup>th</sup> July, 2003, the Board of Directors in its 98<sup>th</sup> meeting held on 29<sup>th</sup> September - 2004, has accorded approval regarding the recruitment to the post of JEN Accounts Officer, Accountant, Junior Accountant and Helper:

1. The procedure of recruitment shall be as laid down in the Annexure B circulated alongwith agenda note and initialed by the Managing Director for the purpose of identification. The Chairman is authorised to carryout necessary modification wherever required in context to Ajmer Discom;
2. Considering preference to Ex-Servicemen in recruitment of Technical Helper provided that they fulfill eligibility and other criteria for recruitment;
3. Keeping retirement age of Linemen and other similar posts unchanged.
4. Conversion / up-gradation of 284 existing vacant posts of Helper Gr. II as Technical Helper alongwith creation of 339 new posts in the pay scale of Rs. 2950-4475.
5. Adoption of Government order dated 29.10.05 for disqualifying candidates having more than two children from recruitment / service and amending Service Rules accordingly, and
6. Making provisions by amending Service Rules for giving services of Technical Helper on deputation to the Franchisees and also indicate this condition in Advertisement.
7. The recruitment to the post of Accounts Officer may be continued to be filled through Campus Interview from amongst persons possessing C.A. Qualification. Preference may be given to persons having relevant experience in PSUs.
