
**Sub: - Amendment in the Delegation of Powers.**

The Board of Directors in their 16<sup>th</sup> meeting held on 4<sup>th</sup> March 2002 has accorded approval for insertion of the following new item in the Manual of Delegation of Powers.

**In the said Manual**

A new item No. 72 shall be inserted as under : -

Item No.	Nature of Powers	To whom Delegated	Extent of Delegation.
72	Any claim of supplier/ contractor against any purchase work/ order which has become time barred under Section 3 of Limitation Act. 1963, and such supplier/ contractor makes an application or request to entertain such claims for payment, such delay may be condoned.	Concerned AEN with the concurrence of circle A.O. Concerned XEN with the concurrence of Circle A.O. Concerned SE with the concurrence of CAO. Chief Engineer with the concurrence of FA & COA. Chairman & Managing Director.	Claims up to Rs. 10,000/- Claims above Rs. 10,000/- but upto Rs. 25,000/- Claims above Rs. 25,000/- but upto Rs. 50,000/- Claims above Rs. 50,000/- but upto Rs. 1,00,000/- Claims above Rs. 1,00,000/-



Note(s) :-

- i) The period of limitation shall be counted from the date on which the claim becomes due.
- ii) In case any supplier or contractor is involved in more than one purchase/ work order awarded by same or other authority of the company the Limitation Act, 1963 shall be applied for each purchase/ work order.
- iii) An indemnity bond in the prescribed format mentioning that the payment for which claim is submitted has not been received by him (claimant) would also be necessary.
- iv) The above powers are to be exercised after scrutinising/ vetting the case from the Accounts Wing attached with the office.
