ORDER-68

Sub:- Amendment / insertion in the procedure of direct recruitment to the post of Junior Engineer-I (Contract) on contract basis.

The Board of Director in its 37th meeting held on 12 June '2003 has accorded approval for making amendment / insertion in the existing procedure of direct recruitment to the post of Junior Engineer-I.(Contract) as follows:-

In the said procedure :-

- (i) The existing procedure prescribed under sub heading " **Scrutiny of Applications**" of the procedure of Direct Recruitment to the posts of Junior Engineer- I (Contract) be substituted by the following :-

"Applications received shall be scrutinized and a merit list of eligible candidates for each category, shall be prepared on the basis of marks obtained in the Degree in Engineering. Candidates, **limited to three times of the vacancies**, shall be called for verification of their testimonials and interview, by the Interview Committee, to be constituted by the Chairman & Managing Director. The selection shall be made by giving 80% weightage to the marks obtained in Engineering Degree and remaining 20% weightage to their performance in interview."

- (ii) Under sub-heading qualification of the post of Junior Engineer- I (Contract) within bracket the word **Civil** shall be added after tele -communication.

- (iii) A new clause may be inserted under sub heading scrutiny of applications as follows :-

RESERVATION OF POSTS : The reservation of post for SC/ST/OB/Physically handicapped / women candidates will be as per State Government relevant provisions in this regard.

(iv) The existing procedure prescribed under sub heading "Age" be substituted by the following:-

The candidates must have attained the age of 21 years and must have not exceeded the age of 35 years on the first day of January, next. The maximum, age may be relaxed as per State Government's relevant provisions in this regard.

Further the Board of Directors has also approved the ratio of 50% : 50 % to fill up the posts of Junior Engineer-I (C) and Junior Engineer-II(C)
