
ORDER-21

Sub:- Regularization of Strike period w.e.f 08.12.2015 to 12.12.2015.

The Coordination Committee in its 3rd meeting held on 28.02.2017 has decided that Managing Director of the concerned Power Sector Company shall take decision regarding regularization of strike period w.e.f. 08.12.2015 to 12.12.2015 on case to case basis after finalization of disciplinary/criminal proceedings, if any, to avoid break in service. Pursuant to said decision, it is decided that:-

1. Absence period of those employees against whom no disciplinary action/criminal case was initiated be regularized by grant of Extra Ordinary Leave (Leave without Pay) by the concerned competent authority to avoid break in service, however, this period will not be counted as service for pensionary purpose or any other service benefit.
2. The period of suspension/absence/custody of such employees against whom disciplinary /criminal case instituted for participating in strike, instigating others, disrupting power supply etc. shall be regularized as per outcome of departmental enquiry proceedings/criminal case, as the case may be .
