

Terms & Conditions:-



A photo copy of joining report of concerned employee be sent by the controlling officer to this office through email on mailing address secy.admn1ajmer@gmail.com, otherwise it shall be presumed that the promotee incumbent is not interested to join on promoted post.
2. If he is not interested to avail the promotion, request in writing about foregoing the promotion shall be obtained by the controlling officer from him and forward the same to this office.
