Keeping in view the recommendation of the Departmental Promotion Committee Year held on 26.12.2017 for the post of Addl. Chief Engineer(E&M) and as approved by the appointing authority in exercise of powers conferred under regulation 32 of AVVNL Engineers Service Regulation-2016 read with the Part-III of AVVNL revised guidelines of DPC (AVVNL-Rule 755), Sh. J.S. Manjoo, Superintending Engineer (E&M) is hereby appointed on promotion to the post of Addl. Chief Engineer (E&M) with immediate effect purely on urgent temporary basis and in officiating capacity for a period of six months in first instance or till his regular selection or till attaining the superannuation age or till the selected candidate on the recommendation of selection committee becomes available or till further orders, whichever is earlier.

Apart from above, this temporary promotion in an officiating capacity shall be governed with the following terms and conditions as stipulated in sub-regulation 8 of Part-II of AVVNL revised guidelines of DPC (AVVNL-Rule 755):-

1. This promotion is being made on urgent temporary basis without providing any right of regular promotion.
2. The promotion may be reverted any time.
3. The promotion shall not confer any benefit of seniority.
4. The promotion shall not affect eligibility and seniority for regular promotion on higher post and there will not be any change in their seniority.
5. The above urgent temporary promotion will not be the basis of demand for regular promotion.
6. The adhoc promotion will not affect reservation quota.

The above promotion on temporary basis and in officiating capacity shall be and in officiating capacity subject to the final outcome of the SBC Writ Petition No. 5368/2005 M. B. Pliwal V/s AVVNL before Hon'ble RHC, Jodhpur and the SBC Writ Petition no. 11809/2014 filed by S. S. Meena V/s AVVNL & others before Hon'ble RHC, Jaipur.

Accordingly, Sh. J.S. Manjoo is hereby posted as Addl. CE (JN/Z), AVVNL, Jhunjhunu and he will also look after the work of the SE(O&M), Jhunjhunu till regular posting of SE(O&M), Jhunjhunu.
