Terms & Conditions:-

The controlling officer shall personally ensure compliance of following conditions in respect of promotee Statistical Assistant. In case following conditions are not satisfied in respect of above employee, the matter shall be reported by him to corporate office instead of taking joining report on the post of Statistical Assistant.

1. All the aforesaid employees will have to join their duties within 15 days of issuance of order by submitting joining report to the controlling officer as indicated in above column No. 4. A photo copy of joining report of concerned employee be sent to this office by the controlling officer.
2. If any one is not interested to avail the promotion, request in writing about foregoing the promotion shall be obtained by the controlling officer from him/her and shall be pasted in service book. On foregoing promotion he/she shall not be considered for promotion for next two DPC years. The benefit of 2nd & 3rd selection grade shall also be withdrawn from the date he/she foregoes the chance of promotion, as per order No. RSEB/F&R/F.16(13)/I/D. 40 dated 25.07.1997.
3. Such candidates who are getting selection grade/ACP in the Pay scale/Pay band and Grade pay of Statistical Assistant or higher will not be allowed further fixation of pay in the Pay scale/Pay band and Grade pay of Statistical Assistant, however, if anyone is getting ACP in lower grade than Statistical Assistant, he/she will be allowed only the difference of Grade pay of the post of Statistical Assistant.
4. The concerned controlling officer will ensure that if an employee has been transferred to any other office, intimation to this regard be given to this office immediately.
