

Terms & Conditions:-



In such case, the benefit of selection grade/ACP, availed if any, shall also be withdrawn from the date of foregoing the chance of promotion, as per order no. RSEB/F&R/F. 16(13)/I/D. 40 dated 25.07.1997 or as per other applicable orders issued on the subject from time to time.
3. Such candidates who are getting selection grade/ACP in pay scale of OS-II or higher will not be allowed any further fixation of pay in the Pay Scale of OS-II.
