

1. Apart from above, the incumbent shall also submit his property declaration statement as per rules alongwith joining report. 2. If he is not interested to avail the promotion, request in writing about foregoing the promotion shall be obtained by the controlling officer from him and forward the same to this office. An entry in this regard be made in his service book. In such case, the benefit of selection grade/ACP, availed if any, shall also be withdrawn from the date of foregoing the chance of promotion, as per order no. RSEB/F&R/F. 16(13)/D. 40 dated 25.07.1997 or as per other applicable orders issued on the subject from time to time.
3. If he is already getting selection grade/ACP in pay scale of AEN (E&M) or higher will not be allowed any further fixation of pay in the Pay Scale of AEN (E&M).
