OFFICE ORDER

As per Order No. 1834 dated 22-09-2005 (Rev. AJ-49) read with subsequent order issued vide No. 1895 dated 03-10-2005 (Rev. AJ-51), No. 2227 dated 22-11-2005 (Rev. AJ-52), No. 2277 dated 29-11-2005 (Rev. AJ-53) & No. 387 dated 08-06-2006 (Rev. AJ-63) adhoc payment of energy bills based on pre-revised tariff, is being accepted from agriculture consumers (except farm house consumers not getting supply in blocks).

Since the State Govt., vide its order No. F-13 (27)Energy/2003 dated 18-11-2006 have decided that burden of tariff hike for agriculture consumers (except farm house consumers not getting supply in blocks) in view of RERC tariff order dated 17.12.2004 will not be passed on to such consumers and instead shall bear such burden by providing subsidy to all the three distribution companies, the agriculture consumers (except farm house consumers not getting supply in blocks) shall continue to pay their energy bills on pre-revised tariff basis.

In Order to implement the above decision, following instructions are conveyed to compliance by all concerned.


- (i) Ad-hoc billing applicable to consumers at present, would no longer remain in existence after the billing month of Nov. 2006.
- (ii) Rebate @ 10 paisa per unit for agriculture metered consumer using sprinklers or drip system of farming allowed vide this office No. 836 dated 23-06-2005 (Rev. AJ-44) shall now be applicable only to farm house connection receiving 24 hours supply.
- (iii) Relief in billing of agriculture flat rate consumers made applicable vide the office No. 836 dated 23-06-2005 (Rev. AJ-44) & No. 1590 dated 29-08-2005 (Rev. AJ-48) is withdrawn with immediate effect.
- (iv) With effect from billing month Dec. 2006, billing in respect of all the agriculture consumers (except farm house consumers not getting supply in blocks) assessment would be shown in Ledger and also in energy bills as usual on the basis of revised tariff 2004 but demand from such consumers will be made on pre-revised tariff i.e. in accordance with the provisions under tariff 2001, showing the amount of difference of two tariff (2004 & 2001) as realization through adjustment in MIS, and consumer ledgers. Amount of the difference to be treated as subsidy receivable from the State Govt., shall be booked under transaction code 51.


- (v) The amount of subsidy provided by the Govt. shall be conspicuously depicted in the energy bill in bold letters.
- (vi) Prior to commencement of billing of Dec. 2006, the computer agencies will work out the difference of amount relating to revised tariff 2004 and pre-revised tariff 2001, less element of subsidy already allowed in view of relief announced by the State Government earlier and credit the same to such consumers. This should be worked out in respect of all such affected agriculture consumers (except farm house connections receiving 24 hours supply i.e. tariff code 4700, 4711 & 4712 in urban areas and 4800, 4810 & 4811 in rural area), w.e.f the billing Oct 2005. The amount so worked out would be shown as realization through adjustment in consumers ledgers and in MIS so that the amount remaining unpaid by such consumers is only on pre-revised tariff at the end of November 2006.

The order shall come into force with immediate effect.
