CIRCULAR


It is observed that the changeover from LT to HT supply is not effected by Sub-divisions if MDI exceeds 50 KVA more than two times in a financial year. Even Sub-divisions are not issuing notices of one month which is required as per terms and condition for supply of electricity-2004.

The clause No. 13 mentioned in terms and condition for supply of electricity-2004 is reiterated below.

" Changeover from LT to HT supply shall be effected if maximum demand as per MDI exceeds 50 KVA more than two times in a financial year. The consumer in such a case shall have to take supply on 11 KV within the notice period of one month to be issued by Asstt. Engineer concerned after the maximum demand has exceeded third time, failing which his connection would be disconnected."

Therefore, it is enjoined upon all concerned Assistant Engineers to ensure compliance of above mentioned clause. The proforma of notice is enclosed in which one month notice should be issued invariably by concerned Assistant Engineer.
