

ORDER

As per Commercial Order Vide No. AVVNL/Dy. CE/Comml. /XEN-I/F-57/(F) 2010/ D. 273 Ajmer dated 03.05.2010 (Comml. AJ-448), a surcharge termed as Urban Cess has been levied by the State Govt. @ 10 paisa per unit on energy consumed by various categories /classes of consumers except those exempt under the aforesaid order. With a view to implement the aforesaid Order, following instructions are hereby conveyed for strict implementation by all concerned :-


1. Tariff codes of consumers falling under the jurisdiction of a municipal area will now be of a six digit code. To clarify further, initial-4 numeric digit will also continue as usual whereas 5th letter digit, if applicable, will also continue as usual. . In case there is no requirement of any letter code at 5th place, the same will be marked and shown as "X", against such consumer, besides letter code "A", at 6th place.
Existing letter code "X", being utilized for charging of concessional electricity duty from the seasonal industries will no more remain in force for this purpose and the same will be replaced by a newly allotted letter code "b", by the billing agencies from 1st May-2010. This newly allotted (b) will also be utilized by the unit Officers for filling MF-1 of all the aforesaid prospective consumers.
2. List of binders falling under the jurisdiction of a municipal area will be provided by the unit officer to the billing agency, with effect from 1.05.2010. Name of municipal body must be indicated on top of the list to be so prepared and provided, since the same needs to be provided separately, for each municipal body. In case any binder comprises of consumers under municipal and non-municipal area both, accounts number wise six digit tariff code of such individual consumers will also be provided by the unit officer to the billing agency w.e.f. 01.05.2010.
3. Six digit tariff codes will further be mentioned invariably on MF-1 of the aforesaid consumers, by the unit officers w.e.f. 01.05.2010. Name of municipal body must also be mentioned and shown on top of the such MF-1.
4. The billing agencies will calculate the amount of "Urban Cess" @ 10 paisa per unit, on the applicable consumer from billing months May-2010. The amount of this "Urban Cess" will also be indicated by the billing agencies separately in the revised performa of energy bills.
5. The billing agencies will ensure to keep and compile the data relating to assessment, realization and outstanding of this "Urban Cess" separately, municipal body wise.
6. The billing agencies will also generate a municipal body wise monthly report of assessment, realization and outstanding of this "Urban Cess" and provide the same to the unit officers concerned . Sub-division wise and municipal body wise this report will be also be provided by agencies to the circle Accounts Officers under copy to the CAO (Rev.) , invariably.
7. Basis of applicability of 100 unit per month consumption and respect of the bi-monthly billed domestic consumers under the municipal areas will be

- considered and applied taking into account of the months of consumption relates. To clarify further, if consumption of any bi-monthly billed such consumer is up to 200 units, the aforesaid urban cess will not apply but wherever this consumption exceeds and comes to 201 units or more, the urban cess will be applicable on the whole consumption.
8. Exemptions allowed for the various category/class of consumers under the existing letter codes/tariff codes will continue as usual.
 9. Copy of revised bill performa is enclosed for implementation, Accordingly, the revision of ledger and other output reports may be done and generated by billing agency.
 10. A new transaction Code 60 is hereby prescribed for the debit/credit or adjustments relating to the "Urban Cess".
 11. A new transaction Code 61 is hereby prescribed for the debit/credit or adjustments relating to the "Water Consumption Cess".
 12. The Accounting code as allotted and circulated vide NO/ AVVNL/ CAO/ A/C's/ Sr. AO/A/C's//F----/D. 553 . Dated 04.05.2010 (Copy enclosed) will be utilized for booking of transaction of the "Urban Cess".
