

ORDER

Sub: - Grant of Dearness Allowance to AVVNL employees.

- (1) In exercise of the powers conferred vide order No. AVVNL/CAO(R&C)/AAO(Rule)/F-15/ OO/D.3416 dated 05.12.2011(AVVNL-Rule-527), the Managing Director, AVVNL is pleased to adopt the State Government's order No. F.6 (3)/FD (Rules)/ 2017 Jaipur, dated 25.10.2021 issued by the Finance department, GOR. Accordingly, the existing rate of Dearness Allowance payable to the employees of the Nigam vide this office order No. AVVNL/CAO(ERB)/AAO(Rule)/F.1(3) /OO/D.1583 Dated 22.07.2021 (AVVNL- Rule-965) shall be revised from 28% to 31% w.e.f. 01.07.2021.
- (2) The term 'Pay' for the purpose of calculation of Dearness Allowance shall be the Basic Pay i.e. pay drawn in the pay matrix of the prescribed levels and shall not include any other type(s) of pay like special pay or personal pay etc.
- (3) The payment on account of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.
- (4) The amount of increase in Dearness Allowance for the period from 01.07.2021 to 30.09.2021 shall be credited to the GPF-SAB account and cash payment shall be admissible from 01.10.2021 i.e. salary for the month of October, 2021 payable on 01.11.2021.


