ORDER - 10

Sub:- Payment of Bonus/Ex-gratia for the accounting year 2000-2001.

The Board of Directors in their 11th meeting held on 20th October 2001 have decided to make payment of Bonus/Ex-gratia for the accounting year 2000-2001 @ 8.33% of the salary or wages as the case may be, to

- (i) the employees/officers of erstwhile RSEB transferred to AVVNL under the provisions of the Rajasthan Power Sector Reforms Transfer Scheme 2000.
- (ii) the employees/officers appointed on or after 20-7-2000 on a post in the A.V.V.N.L and
- (iii) the employees/officers of erstwhile RSEB who retired during the period between 1.04.2000 to 19.07.2000.


The entitlement of each individual employee would be determined and disbursement made in accordance with the instructions contained in erstwhile RSEB order No. RSEB/F&R/F.48(14)/D.84 dated 7th October, 1998.

In case an employee/officer is getting salary more than Rs 2500/- the amount of bonus/ex-gratia shall be calculated as if the salary /wages of the employee/officer was Rs 2500 - (Rs Two thousand five hundred) only per month.

The payment of Bonus/Ex-gratia as above shall be arranged from 5th to 12 November 2001. Payment to employees/officers of erstwhile RSEB who retired on or before 19.7.2000 shall be made by respective offices of erstwhile RSEB from where the concerned employees/officers had retired and will be debited to the Account of RVPN and Inter Company Debit Note raised to Accounts Officer (Budget). RVPN, Jaipur.

No overtime/honorarium will be allowed to any of the employee for preparing/passing of the claims in regard to payment of Bonus/Ex-gratia.
