Sub: - Revision/update of family pension in respect of Nigam employees who retired/died on or after 1.9.1988 but before 1.9.96.

In exercise of the powers conferred vide order No.RVPN/ADMO/AS/CC/F&R/D.205 dated 01.12.2001 the Chairman and Managing Director, RRVPN, in consultation with Director (F&A) has been pleased to adopt mutatis mutandis the manner/procedure contained in the Memorandum of Govt. of Rajasthan bearing No.F.15 (2) FD (Rules) 98 dated 15.04.1999 for revision /update of family pension w.e.f. 01.9.1996 for the pensioners/family pensioners of the Nigam.


Accordingly, the procedure for consolidation of family pension of employees who retired/died between 1.9.1988 to 31.8.1996 and whose last pay drawn exceeded Rs.1330/- is further simplified in the manner given below: -

1. The existing family pension shall be consolidated w.e.f. 1.9.1996 in accordance with the provisions of erstwhile RSEB order No.47 dated 23.6.1998.
2. Family pension shall be re-calculated @ 30% of the last pay drawn by the pensioner/deceased employee in the pay scale effective from 1.9.1988 and the difference between the family pension already admissible under slab system and @ 30% of last pay drawn shall be worked out. The upper ceiling of pension/family pension shall be 50% and 30% respectively of the highest pay in Nigam, which is Rs.20,000/- from 1.9.1996.
3. The Addl. family pension becoming due on account of the difference between family pension already admissible under slab system and at the rate of 30% of last pay shall be added to the consolidated family pension worked out as at (1) above. The total of these two amounts i.e. the consolidated family pension + Addl. family pension shall be basic family pension w.e.f. 1.9.1996 payable w.e.f. 1.1.1997 and shall be subject to the prescribed limits.



4. Dearness relief on the basic family pension as at (3) above shall be admissible in accordance with the orders issued from time to time w.e.f. 1.1.1997.
  5. Where the consolidated family pension works out to an amount less than Rs.1275/-, the same shall be raised to Rs.1275/-. This will be regarded as minimum family pension w.e.f. 1.9.1996 payable w.e.f. 1.1.1997
  6. In the case of existing pensioners in whose case the family pension has not come into operation as the pensioner was alive on 1.9.1996 & even today they are alive, the rate of family pension at enhanced rate wherever applicable and at normal rate will also be updated and consolidated in terms of this order. The updated rates of family pension will apply as and when family pension becomes payable in such cases.
  7. An example regarding calculation of basic family pension and enhanced family pension admissible w.e.f. 1.9.1996 is given at Annexure- B.
  8. Arrears if already paid on account of consolidation of family pension including dearness relief thereof as an interim measure in accordance with the provisions of erstwhile RSEB order dated 23.6.1998 shall be adjusted by pension disbursing authorities against arrears becoming due on the revision of family pension and dearness relief admissible on the basis of this order.
  9. Each pensioner/family pensioner, as the case may be who is entitled to the benefit of revision of family pension in terms of this order is required to apply for revision of family pension in the prescribed form in triplicate as at Annexure-A to the Asstt. Secretary (Pension) RVPN, Jaipur.
  10. Two copies of the above formats along with calculation sheet (as per Annexure-B) shall be forwarded to the Accounts Officer(Pension), RVPN, Jaipur for issuing necessary orders to modify the amount of family pension to the existing pensioners. In case of family pensioner revised family pension payment orders be issued by the Chief Accounts Officer(P&F).
  11. For payment of arrear w.e.f. 1.1.1997 to 31.8.2005 orders shall be issued separately. Payment of enhanced family pension from 1.9.2005 shall be payable regularly.


