ORDER - 193

Sub:- Revival of the post of Vehicle Drivers and filling up to these posts through Limited Direct Recruitment procedure.

The Board of Directors in its 98th meeting held on 29th September - 2006 has decided for appointing the persons against vacant posts through the process of internal direct recruitment as one time action, as follows:-

1. The provisions made in Schedule - III appended with RSEB TWSR, 1975 for direct recruitment to the posts of Vehicle Drivers be followed for internal direct recruitment.
2. The vacant posts of Vehicle Drivers may be filled in by selecting the candidates from existing employees of the Companies working in other trades and a selection committee at corporate level may be constituted by each Company to select the candidates. The said Committee may adjudge the suitability of the employee for their appointment subject to confirmation / certification that:-
 - a. In the office concerned there are no vehicles in excess of norms / requirement.
 - b. The old vehicles have been surveyed and deposited with the authority concerned.
 - c. Drivers will be screened for the vehicles on road only.
 - d. Helpers / Class - IV servants are not being used in those places / offices where regular Vehicle Drivers are existing.
 - e. In the regular sanctioned strength of Vehicle Drivers, those cases / posts would not be included which have been sanctioned for a particular period / project.
 - f. Any other specific / general order / resolution of the erstwhile Board / Successor Company / CMD has been considered.
3. The aforesaid Committee shall submit its report to the CMD / MD for obtaining approval of Board of Directors to appoint the Nigam employees working in other trades on the post of Vehicle Drivers and their fixation will be made under regulation 24 of RSEB ESR, 1964, with the specific mention that if the pay and pay scale of such employees is higher than the maximum of the pay and pay scale of vehicle drivers due to sanction of 1st, 2nd, 3rd selection grade, the same shall be protected.
4. The posts presently held by the persons who are selected and appointed as drivers by way of internal direct recruitment as above, will be abolished.
