This is subject to ratification by the Board of Directors of AVVNL.



CLARIFICATION


Sub:- Prescription of selection grades for the employees in the Revised Pay Scales effective from 01.09.1996 & fixation of pay in such selection grades.

Para 4 of the erstwhile RSEB's order No.RSEB/F&R/F.6(iv)/D.31 dt.17.04.1998 , as amended from time to time provides that :-

"In case of employees drawing pay in selection grades of pay granted under Board's order No. RSEB/F&R/F. 16(iii)/D. 11 dt.06.03.1992 , as amended from time to time , the revised selection grades shall be the corresponding pay scale as indicated in Appendix 'A' appended with order No. RSEB/F&R/F.46(21)III/D.30 dated 17.04.1998. If the existing selection grade , revised as per above is lower than the selection grade admissible under this order,(i.e. pay scale of promotionary post as per para 1 or selection grade for isolated posts as per para 2 of this order), the pay of the employee shall first be fixed in the corresponding revised pay scale as per Appendix "A" appended with order No. 30 Dt. 17.04.1998 and then refix w.e.f. 01.09.1996 in the higher selection grade pay scale corresponding to the promotionary post as per this order at equal stage and if there is no equal stage, then at the next above stage."

References have been received to clarify as to how the next date of AGI shall be determined in case of fixation of pay at next above stage in place of equal stage under the provisions of para 4 supra.

The matter has been examined and it is clarified that in case of fixation of pay of an employee under the provisions of para 4 of erstwhile Board's Order No.RSEB/F&R/F. 6(iv)/D. 31 dt. 17.04.1998, as amended from time to time , happens to be made at next above stage in place of equal stage after fixation of his pay under the provisions of Rule 11 of RCS (Revised Pay Scales) Rules, 1998 the next Annual Grade Increment shall be admissible after completion of full incremental period of one year from the date of fixation of his pay as above.

It is enjoined upon the authorities making fixation of pay in the revised Pay scales effective from 1.9.96 that in case where next date of AGI has been determined in any manner different from what is contemplated in this clarification shall be reopened and the next date of AGI shall be revised as per the above clarification.

Strict compliance of the above clarification should be adhered to. Any lapse on this account would be viewed seriously.
