Subject : Revision of pension of Pre-01.09.2006 State Pensioners.

In supersession of existing para 13 of Finance Department Memorandum No. F.12(3)FD(Rules)/2008 dated 12.09.2008, the Governor is pleased to order that in the cases of State Government employees who have been permanently absorbed in Public Sector Undertakings / Autonomous Bodies and have drawn one time lump sum terminal benefit equal to 100% of their pension, in their cases 1/3rd of pension already restored may be revised as under w.e.f. 01.09.2006: -

- A. As on 01.09.2006, the full pension of the absorbees shall be notionally revised w.e.f. 01.09.2006 based on full pension as on 31.08.2006 in accordance with Finance Department Memorandum No. F.12(3)FD(Rules)/2008 dated 12.09.2008. Benefit of additional pension available to old pensioners will be granted as indicated in item C below.
- B. The restorable 1/3rd pension shall be the sum of the following: -
- i. 1/3rd of original pension / consolidated pension as on 31.08.2006.
 - ii. Dearness Pension @ 50% of original pension / consolidated pension under Finance Department Order No. F.6(3)FD(Rules)/2004 dated 24.05.2004, where applicable.
 - iii. Dearness Relief @ 24% of original pension / consolidated pension plus Dearness Pension.
 - iv. Fitment weightage @ 40% of the original pension / consolidated pension.
- C. The quantum of 1/3rd restorable pension as per para B above shall be further increased in respect of old pensioners as follows: -

Age of Pensioner	Additional Quantum
From 80 years to less than 85 years	20% of revised 1/3 rd restorable pension
From 85 years to less than 90 years	30% of revised 1/3 rd restorable pension
From 90 years to less than 95 years	40% of revised 1/3 rd restorable pension
From 95 years to less than 100 years	50% of revised 1/3 rd restorable pension
100 years or more	100% of revised 1/3 rd restorable pension

The amount of additional pension will be shown distinctly in the pension payment order.

- D. Payment of Dearness Relief shall be on original pension / consolidated pension including Additional Pension, if any, as per instructions issued from time to time and is subject to the condition that the absorbed employee was not re-employed / employed under the Central Government or State Government or a Corporation / Company / Body / Bank under them in India or abroad, including permanent absorption in such Corporation / Company / Body / Bank at the time of restoration.

2. **Non-accrual of Arrears for the period from 01.09.2006 to 31.12.2006: -**
Notwithstanding anything contained in this order, no arrears shall be payable for the period from 01.09.2006 to 31.12.2006 on account of consolidation of pension.


