ORDER

In view of the orders dated 12-10-2009 and 4-11-2009 passed by the Hon'ble High Court, Jaipur Bench in D.B. Civil Writ Petition (PIL) No. 12810/09 G. Sharma Vs. State of Rajasthan, restricting the vertical reservation to 50%, in partial modification of this Department's order of even number dated 8th February, 2010, the State Government, being of the opinion that the Special Backward Classes are not adequately represented in the services under the State, hereby orders that 1% reservation in recruitments and admissions shall be provided to the Special Backward Classes in addition to the reservation provided vide order dated 8th February, 2010. This reservation shall be given to the Special Backward Classes in addition to reservation available to them in Backward Classes. Only those Special Backward Class candidates who do not come in merit among Backward Classes shall get the benefit of this reservation.

This order shall remain in force till the Hon'ble Rajasthan High Court passes any further order or decision in the DB Civil Writ Petition (PIL) No. 12810/09 G. Sharma V/s State of Rajasthan.

आदेश

डी. सी. सिविल रिट याचिका सं. 12810/2008 जी. स्याल नाम राजस्थान राज्य में माननीय उच्च न्यायालय के आदेश को 50 प्रतिशत की सीमा में रखने के आदेश दिनांक 4.11.2009 को दृष्टिगत रखते हुए राज्य सरकार ने यह निर्णय लिया है कि तत्काल प्रभाव से आदेश संबंधी मामलों में न्यायालय का अन्तिम निर्णय होने तक को अवधि में भर्ती के लिए विज्ञापित पदों के 4 प्रतिशत विशेष पिछड़ा वर्ग एवं 14 प्रतिशत आर्थिक पिछड़ा वर्ग के अतिरिक्त नोशनल पद निर्धारित किये जा कर रखे जायेंगे तथा न्यायालय द्वारा राजस्थान अनुसूचित जाति, अनुसूचित जनजाति, पिछड़ा वर्ग, विशेष पिछड़ा वर्ग और आर्थिक पिछड़ा वर्ग (राज्य की शैक्षिक संस्थाओं में सीटों और राज्य के अधीन संस्थाओं में नियुक्तियों और पदों का आक्षण) अधिनियम 2008 को वैध घोषित होने की परिस्थिति में निर्धारित पद उक्त अधिनियम के प्रावधानों के अनुसार विशेष पिछड़ा वर्ग और आर्थिक पिछड़ा वर्ग से भरे जाने के लिए उपलब्ध कराये जायेंगे।

राज्य सरकार ने यह भी निर्णय लिया है कि तत्काल प्रभाव से उक्त रिट याचिका का निर्णय होने तक की अवधि में निर्धारित आयु सीमा धार करने वाले अभ्यर्थियों को आयु सीमा में छूट का लाभ देय होगा।

अतः प्रत्येक नियुक्ति प्राधिकारी उक्त अवधि में भर्ती के लिए विज्ञापित पदों के 4 प्रतिशत विशेष पिछड़ा वर्ग एवं 14 प्रतिशत आर्थिक पिछड़ा वर्ग पद राज्य सरकार के उक्त निर्णय के अनुसार निर्धारित कर कार्मिक विभाग को सूचित करेगा।

कार्मिक विभाग इस प्रकार निर्धारित पदों का एक रजिस्टर में अभिलेख संघारित करेगा।




