

Grant of ACP to an AEN appointed by direct recruitment /LDR who has been granted first selection grade in the pay scale of Rs. 9000-14400/- and has been promoted on the post of XEN prior to 01.09.2006, and has drawn the selection grade of XEN (prior to 01.09.2006) then, he will not be entitled to ACP. In case the XEN has not drawn the selection grade of XEN i.e. Addl. S.E. or not promoted as S.E. (upto 01.09.2006), then his ACP shall be as illustrated below:-
