Note below Direct Recruitment of Jr. Accountant, Accountant & Accounts Officer.

"MBA (Finance) approved by a recognized University of All India Council for Technical Education (AICTE) & M.Com. qualification approved by a recognized University must be of minimum 2 year's duration and acquired as a regular student. It doesn't include any qualification through distance learning programme. However, it includes 2 year's PG Diploma in Business Management declared equivalent to MBA (Finance)".

Note below Fast Track Promotion of Accountant, Assistant Accounts Officer & Accounts Officer:-

"MBA (Finance) approved by a recognized University or All India Council for Technical Education (AICTE) must be of minimum 2 year's duration and acquired as a regular student or through distance learning programme/correspondence course. The distance learning programme must be approved by the Distance Education Council (DEC). However, it includes 2 year's PG Diploma in Business Management declared equivalent to MBA (Finance)".
