**ORDER**

**Sub:-** Grant of Ex-gratia payment to widows of deceased Contributory provident Fund Retirees/ employees of E&M Department, GoR.

In exercise of the powers conferred vide order No. AVVNL/CAO/ Rules/ F./(13)/D-505 dated 03.11.2001 (Order-11), the Managing Director, AVVNL, is pleased to adopt the Finance Department, Government of Rajasthan's Memorandum No. F.15(3)FD(Rules)/98 dated 30.03.2010 (Copy enclosed) regarding grant of ex-gratia payment to widows of deceased Contributory provident Fund Retirees. Accordingly, the Ex-gratia payment to widows of deceased Contributory provident Fund Retirees/employees of E&M Department, GoR, has been revised from Rs. 1293/- to Rs. 2500/ per month w.e.f. 01.04.2010 plus dearness relief as may be admissible thereon from time to time to the alive widows of deceased employees of erstwhile E&M Department on the same terms and conditions set out in the erstwhile RSEB's order No. RSEB/F&R/F.3(12)/D.2 dated 06.01.1999. The payment of arrears w.e.f. 01.04.2010 to 30.06.2010 shall be made with the ex-gratia payment of July - 2010, payable in Aug-2010.


**Subject: Grant of Ex-gratia payment to widows of deceased Contributory Provident Fund Retirees.**

The undersigned is directed to invite attention towards Finance Department Memorandum of even number dated 06.02.2009 vide which Ex-gratia payment to alive widows of Jodhpur Contributory Provident Fund Retirees / beneficiaries, who died while in service, was revised from Rs.572/- per month to Rs.1293/- per month w.e.f. 01.01.2007 plus Dearness Relief, as may be sanctioned from time to time to the State pensioners.

Keeping in view the extreme financial hardship caused to these widows in old age, the matter has further been considered and the Governor is pleased to order that the Ex-gratia payment admissible to the aforesaid widows may be revised to Rs.2500/- per month plus Dearness Relief as may be sanctioned from time to time to the State pensioners.

This order shall come into force with effect from 01.04.2010.


