Sub: - Amendment in the Purchase Manual - 1999.

The Co-ordination Committee in its 139th meeting held on 17.06.2010 has considered and approved the following amendment in the erstwhile RSEB Purchase Manual 1999.


In the said manual:-

The existing clause No. 23.12 shall be substituted by the following:-

The purchase authority reserves the right to sanction placement of repeat order on the same supplier(s) for quantity equal to 15% of the originally ordered quantity after recording reasons and obtaining approval of competent purchase committee provided such order(s) shall not be given after expiry of three month from the 'last date of scheduled supply' of the original order(s) and also subject to condition that the prices have since not reduced and original purchases were made after calling of tenders through wide publicity. Prices for the suppliers against additional orders if placed, as well as remaining/balance supplies against previous / old orders would be regulated as per provisions of Para No. 26.24 of the Manual provided CLPC shall however have full powers to approve purchase of any quantity but upto quantity of original orders for reasons to be recorded in writing.

This is subject to ratification by the Board of Directors.


