
**ORDER**

**Sub:-** Amendment in the Rajasthan Civil Services (Medical Attendance) Rules, 2008.

In exercise of the powers conferred vide letter No. AVVNL/CAO/Rules/F/(13)/ D-505 dated 03.11.2001 (Order-11), the Managing Director, AVVNL, Ajmer is pleased to adopt the Finance Department, Government of Rajasthan's Notification No. F.6(4)FD(Rules)/2003 dated 06.07.2010 (copy enclosed) regarding amendment in the Rajasthan Civil Services (Medical Attendance) Rules, 2008. It has also been decided that the amendment made in Rule 8 of Rajasthan Civil Services (Medical Attendance) Rules, 2008 at S.No. 3(ii) of the Notification shall be made applicable for the private hospitals empanelled by the Nigam.



- (4) Only one follow-up treatment shall be allowed in cases where treatment has been undertaken in referral hospitals out-side the State as per provisions of Rule 10(1) on the advice of the treating doctor of that hospital. No follow-up treatment shall be allowed in the cases where the treatment has been undertaken in emergent circumstances under Rule 10(3) and in other cases also.
- (5) If the total expenditure on medical attendance and treatment as per the provisions of sub-rule (3) and (4) is more than Rs.5 lacs then the Head of Office will refer the case to the Principal of Medical College to constitute a Medical Board to ascertain the genuineness of the claim. The reimbursement on this account shall be governed as per opinion of the Medical Board and the excess claim, if any, shall be disallowed.\*
- (vi) at the end of existing clause (f) of sub-rule (2) of Rule 13, the following new sentence shall be inserted, namely: -

"In case of reference outside the State, self-attested copy of Outdoor Prescription Slip is to be attached with the claim"


