**Sub:-** Adoption of Government of Rajasthan's order regarding amendment in PWF&AR rules (Part II).


The Co- ordination Committee, in its 138th meeting held on 04.06.2010 has decided to adopt the Government of Rajasthan's order No.F.2(4) FD/PWF&AR/99 Part-II dated 28.05.2010 (Circular No. 46/2010) and Government of Rajasthan's order No. F.2(4) FD/PWF&AR/99 Part-II dated 22.07.2010 (Circular No. PWF&AR 47/2010) for recovery of 1% cess on building works and necessary amendments in Public Works Financial & Accounts Rules (Part- II). Accordingly a new clause shall be appropriately inserted in General condition of Contract (Schedule -II) appended with Purchase manual, 1999 and Works Manual, 2004 by the following, namely :-

"All contracts with Government shall require registration of workers under the Building & other Construction Workers (regulation of Employment & Conditions of services) Act, 1996 and extension of benefit to such workers under the Act. Deductions of cess at source will be made as per provisions of the said Act, in force from time to time."

These are subject to ratification by the Board of Directors.
