**ORDER**

**Sub: - GoR's Notification dated 08.07.09 for regularization of the services of persons irregularly appointed and completed 10 years of service as on 10.04.2006 without intervention of any court or tribunal.**

The Board of Directors, AVVNL, in its 174<sup>th</sup> meeting held on 02.08.2010, has decided to adopt the GOR's Notification dated 08.07.2009 mutatis-mutandis for regularization of the services of persons irregularly appointed and completed 10 years of service as on 10.04.2006 without intervention of any court or tribunal. The Board has also constituted a screening committee consisting of the Secretary (Admn.), Chief Accounts Officer (ATB) and Executive Engineer (Legal) for the purpose.

The Board of Directors further decided that the following new proviso shall be added/inserted after that regulation No. mentioned against each of the service regulations of the Nigam, namely:-

"the persons, irregularly appointed on duly sanctioned posts one completed ten years service on 10.04.2006, without intervention of any court or tribunal and continuously working as such on the date of commencement of these amendment Regulations, (i.e. the date of issue of the order), shall be screened by a Screening Committee consisting of Secretary (Admn.), Chief Accounts Officer(ATB) and Executive Engineer (Legal) provided they were eligible for appointment, as per rules on the date of their initial irregular appointment and vacancy is available at the time of screening. The Board of Directors shall adjudge the services and suitability of the candidate on the basis of the report submitted by the Screening Committee and regularize the services. Thereafter, the Appointing Authority shall issue appointment order of he person and appointment shall be effective from the date of issue of such appointment order".



These persons shall rank junior to the persons appointed regularly before the commencement of these amendment Regulations."
