ORDER

Sub:- Grant of Dearness Allowance to AVVNL employees.

In exercise of the powers conferred vide order No. AVVNL/CAO/Rules/F/(13)/D-505 dated 03.11.2001 (Order-11), the Managing Director AVVNL, has been pleased to adopt the State Government's order No. F.6(1)FD(Rules)/08 dt. 23.04.2010. Accordingly, the existing rate of Dearness Allowance payable to those employees whose pay had not been revised for different reasons or who had exercised an option to continue in the pay scales as contained in the Rajasthan Civil Services (Revised Pay Scales) Rules, 1998, shall be revised as under:

- (i) Out of 61% D.A. sanctioned vide this office order No. 2584 dated 3.12.2004, 50% has been treated as Dearness Pay w.e.f. 01-07-2004.
- (ii) Dearness Allowance @ 73% as indicated at item No. 1(ii) of Nigam's order No. AVVNL/CAO(Rev.)/Sr. AO(Rules) / F.3/00/D.5182 dated 07.01.2010 (AVVNL-Rules-377) payable on both Basic pay and Dearness Pay is further revised to 87% w.e.f. 01-01-2010.

The terms "Basic Pay" for the purpose of calculation of Dearness Allowance shall be the pay as defined in Regulation 3 (xviii) (a) of Employees Service Regulations drawn in the Revised Pay Scale prescribed vide erstwhile RSEB's Order No RSEB/F&R/F46(21) (iii)/D.11 dated 24.02.1998, as amended from time to time, and shall not include any other type(s) of pay like special pay or personal pay, etc. In case of those employees who opt to retain the existing scale of pay, it will include, in addition to pay in the pre-revised scale, dearness allowance and interim relief appropriate to that pay admissible under orders in existence on 01.01.1996,

- 2) The payment on account of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fractions of less than 50 paise may be ignored.
- 3) The amount of increased D.A. i.e. 14% from 01.01.2010 shall be added in the salary for the month of August 2010 and onwards alongwith respective month's salary. Arrears of the increase Dearness Allowance i.e. 73% to 87% for the period from 01.01.2010 to 31.07.2010 will be paid to the employees in one installment i.e. alongwith salary for the month of August 2010 payable in September 2010.
- 4) The payment of D.A./D.A. arrear will also be subject to the terms and conditions laid down in the rules for drawal of D.A. given in Appendix XVI of the R.S.R. Vol. II.
- 5) The increased D.A. shall also be admissible and paid in cash to those employees who were in service on or after 01.01.2010 but ceased to be in service prior to the issue of this order, whether for disciplinary reasons or on account of resignation, retirement, death or discharge or abolition of sanctioned post.
