Sub:- Amendment in erstwhile RSEB Travelling Allowance Rules.

In exercise of the powers conferred vide Order No. AVVNL / CAO / Rules / F.1 (13) / D. 505 dated 03.11.2001, the Chairman & Managing Director, AVVNL, Ajmer has been pleased to adopt the State Government Order No. F. 4 (1) / FA (Rules) / 89 Part Jaipur dated 20.09.2001 and F. 4 (1) FD (Rules)/ 89 dated 12.02.2002 and accordingly the following amendments in erstwhile R.S.E.B. Travelling Allowance Rules -1971 are hereby made with immediate effect :-

In the said Rules :-

- The **appendix A (Pt. II)** - Mileage Allowance for Travel By Road, "Special Rate" in Column -2, the existing words & figures "Rs. 2.50 per KM" shall be substituted by the words & figures "Rs. 3.50 per KM".
- The existing pay mentioned in Column No. 1 of appendix B-II shall be substituted by the following :-

7. Employees drawing pay of Rs. 1800/- & above but below Rs.2200/-.	Employees drawing pay of Rs. 6500/- & above but below Rs. 8000/-.
8. Employees drawing pay of Rs. 1200/- & above but below Rs.1800/-.	Employees drawing pay of Rs. 4000/- & above but below Rs. 6500/-.
9. Pay above Rs. 1200/- .	Pay below Rs. 4000/-.
