**ORDER**

Sub: Amendment in Regulation 12 of the RSEB Employees (CPF Deposit Linked Insurance Scheme) Regulations, 1976 regarding scale of assurance benefits and the minimum average balance to be maintained by an employee.

Pursuant to the Govt. of India gazette notification dated 18-6-2010 the Chairman, Board of Trustees, RRVK CPF Trust, has been pleased to enhance the existing maximum ceiling of Rs.65,000/- to Rs.1.05 lacs. Accordingly regulation 12 of the RSEB Employees (CPF Deposit Linked Insurance Scheme) Regulations, 1976 shall be substituted by the following, namely:-

**Regulation-12** : Scales of assurance benefits and the minimum average balance to be maintained by an employee:

"On the death of an employee who is a member of the RRVK CPF Scheme, the persons entitled to receive the Contributory Provident Fund accumulations of the deceased shall in addition to such accumulations of the deceased be paid on receipt of an application from the claimant in prescribed form through the Head of Office/Controlling officer, an amount of Rs.5,000/- (Rupees Five Thousand) in addition to the amount equal to the average balance in the CPF Account of the deceased during the last 12 months preceding the month in which the death takes place or during the period of his membership which ever is less except, where the average balance exceeds Rs.50,000/- the amount shall be Rs.55,000/- plus 40% of the amount in excess of Rs. 50,000/- subject to ceiling of Rs.1.05 lac."

**Explanation:**

For the purpose of determining the average balance in the fund in relation to any employee, the sum total of contribution by the employee and the employer due for and upto during the relevant period, whether paid or unpaid in the fund together with interest thereon shall be included.

The above amendment shall come into force with effect from 18<sup>th</sup> June 2010 and is issued subject to ratification by the Board of Trustees, RRVK CPF Trust.


