Sub: - Guidelines for retired Nigam employees appointed on contract basis.

The Chairman, Co-ordination Committee in consultation with Director (Finance), RVFN, has decided that the retired employees of Power Sector Companies (i.e. RVFN, RVUN, Jaipur Discom, Ajmer Discom & Jodhpur Discom) appointed on contract basis shall: -

- (i) Be entitled to paid casual leave for 10 days in a year, but during first six months will be entitled to 5 days casual leave only. They will not be entitled to privilege leave or any other kind of leave under ESR. For each days absence without leave 1/30th of monthly remuneration will be deducted.
- (ii) Mark his daily attendance in register maintained for regular employees. Name of such persons shall be included at the end separately and absentee statement shall be prepared on that basis.


