**Sub: - Payment of Bonus / Ex-gratia for the
accounting year 2001-2002,**

The Board of Directors in their 24th meeting held on dated 4th October, 02 have decided to make payment of Bonus / Ex-gratia before Deepawali for the accounting year 2001-2002 @ 8.33% of the salary or wages as the case may be, to :-

- I. All the employees/officers of erstwhile RSEB transferred to AVVNL under the provisions of the Rajasthan Power Sector Reform Transfer Scheme, 2000.
- II. All the employees/officers working/appointed on or after 19.07.2000 on a post in the AVVNL and
- III. The employees/officers of AVVNL who retired during the period between 01.04.2001 to 31.03.2002.


The entitlement of each individual employee would be determined and disbursement made in accordance with the instructions contained in erstwhile RSEB order No. RSEB / F&R / F. 48(14)/D.84 dated 7th October 1998.

In case an employee / officer is getting salary more than Rs. 2500/- per month the amount of bonus/ex-gratia shall be calculated as if the salary / wages of the employee/officer was Rs. 2500/- (Rs. Two thousand five hundred) only per month.

The payment of Bonus/Ex-gratia as above shall ^{be} arranged with immediate effect and be completed before DIWALI.

No overtime/honorarium will be allowed to any of the employee for preparing /passing of the claims in regard to payment of Bonus/Ex-gratia.
