**ORDER**

In partial modification to this office order No. **AVVNL/CAO(R&C)/Sr.AO(Rule)/F.81/00/4571** dated **25.11.2010** (**AVVNL-Rules-450**) following amendments are hereby made. Clause-2, **REGISTRATION (ENLISTMENT) FEE AND REQUIRED SECURITY DEPOSIT**, the revised Security Deposit will be charged as per following table:-

**Clause-4 SECURITY AGAINST THE MATERIALS/EQUIPMNETS ISSUED TO THE CONTRCORS:-**

- (i) The contractor shall be fully responsible for the safe custody of all the equipments/ material issued by **AVVNL** for the execution of work(s) as per quantity mentioned in the bill of material enclosed with the work order(s) till the satisfactorily completion and handing over of the awarded project to the **AVVNL**. For this, the contractor shall take suitable composite storage-cum-erection insurance cover note from scheduled insurance company equivalent to the cost of one time material and erection in hand of the contractor for all the work orders consolidated together. Such insurance will cover any destruction/risk, loss or damage of material by way of theft, missing, damage or deterioration in transit as well as at the site, whatsoever, in part or in full and shall be valid un-till the project/work is satisfactorily completed and handed over to the **AVVNL**. The valid insurance cover note of any nationalized insurance company may be furnished by the contractor while claiming the payment of works. The cost of loss of material to the Nigam on account of any of the reason mentioned in the above clause the contractor would be liable to make good the entire loss by claiming the payment from the insurance agency and depositing the same with Nigam.

- (ii) In addition to above a one-time Bank Guarantee in the prescribed formats and to be issued by any of a scheduled bank shall be furnished by the contractor(s) registered under CLRC towards security and safe custody of the equipments/material issued for execution of the awarded work(s) by the AEN concerned or by any other authorized officer of the AVVNL to the contractor, so as to safeguard against any risk including embezzlement / misappropriation of theft of material amongst others as below:-

It is however security deposit against registration of CLRC fee is refundable at the time of cancellation/withdrawal of registration by the contractor. Both cash security and bank guarantee security will be refundable provided there is no recovery due against the contractor, if there is any recovery due from the contractor the same would be made good from cash as well as bank guarantee taken towards material cost registration security guarantee and other pending payments.
