**ORDER**

The Board of Directors, AVVNL, in its 178<sup>th</sup> meeting held on 19.01.2011, has, accorded its approval to substitute the existing Rule 2 (b) and Rule 5 of the AVVNL Compassionate Appointment of dependants of Deceased Government Servant Rule, 2001, by the following, namely :-

" Rule 2 (b) "Deceased Government Servant" means a person who was employed in connection with the affairs of the state including a member of All India Services of Rajasthan State Cadre and whose pay was debitible to the consolidated fund of the State and who died while in service and, who was:-

(i) Permanent or

(ii) Holding a Post temporarily after appointment on regular, basis and had put in at least three years continuous service including period of probation as probationer-Trainees.

Provided that aforesaid condition of at least three years service shall not be applicable in case of death of an employee/probationer-Trainee due to electrical accidents while performing duty."

**"Rule 5 Appointment subject to certain conditions:-**

- (1) when a Government servant dies while in service one of his/her dependants may be considered for appointment in Government service subject to the condition that employment under these Rules shall not be admissible in cases where the spouse or at least one of the sons unmarried daughters, adopted son/ daughter of the deceased Government servant is already employed on regular basis under the Central/ State Government or statutory Board, Organization/ Corporation owned or controlled wholly or partially by the Central / State Government at the time of death of the Government Servant.


Provided that where the death of first dependant (who was appointed on compassionate basis ) is caused within 5 years of appointment, due to electrical accidents while performing duties, the second dependant may be considered for compassionate appointment, if the first dependant who died due to electrical accident was unmarried or if married had no dependant.

Provided that above conditions shall not apply where the widow seeks employment for herself :



- (2) Appointment under these rule shall be given on the condition that the person appointed on compassionate ground shall maintain properly the other family member who were dependant on the deceased Government servant and on furnishing an undertaking in writing that he/she shall maintain properly the other family members who were dependent on the deceased Government servant. If subsequently, at any time, it is proved that such dependant family members are being neglected or are not being maintained properly by him, the appointment may be terminated by the Appointment Authority after providing an opportunity to the compassionate appointee by way of issue of show - cause notice asking him to explain why his services should not be terminated".
