Sub:- Amendment in Employees Service Regulations, 1964.



(b) The words 'FA&COA' appearing in column 4 of item/serial no. 16 of the Appendix -I, be substituted by the words 'CAO (ATB) /CAO (W&M)/ CAO (R&C)'.
(c) The words Director (I/A)' appearing in column 4 and existing powers appearing in column 5 of item /serial No. 16 of the Appendix-I, be substituted by the following:-

- (i) Upto two months in case of AAO/Accountant/ Internal Auditor.
 - (ii) Full Powers in respect of Technical Officers upto the rank of XEN under his jurisdiction
 - (iii) Full Powers in respect of Class-III employees under his jurisdiction.
