**Sub:- Grant of Dearness Relief to the Pensioners of AVVNL.**


(1) In exercise of the powers conferred vide order No. AVVNL/CAO/Rules/ F/(13)/D-505 dated 03.11.2001 (Order-11), the Managing Director AVVNL, is pleased to adopt the State Government's order No. F. 12(4)/FD (Rules)/2008 dated 23.03.2011 (copy enclosed) regarding grant of Dearness Relief to State Government Pensioners for application in respect of pensioners of AVVNL from 45% to 51% w. e. f. 01.01.2011. Accordingly, the existing rate of Dearness relief payable to the pensioners, as mentioned in Annexure-'D' appended with this office order No. AVVNL/CAO/AAO(Rule)/F.RPS-08/ D. 3076 dated 01.10.2008 (AVVNL-Rule-293) shall be revised from 45% to 51% w.e.f. 01.01.2011.

(2) The provisions of this order shall also be applicable to the pensioners of erstwhile RSEB.

(3) The amount of Dearness Relief at increased rates for the month of April 2011 and onwards shall be paid alongwith pension for respective month.


(4) Further, the Managing Director, AVVNL, in consultation with Director(Finance) has also approved that the arrears of increased Dearness Relief i.e. 45 to 51% for the period from 1.1.2011 to 31.03.2011 will be arranged/released in one installment with the pension of May,2011 payable in June,2011.

**ORDER**

**Subject: - Grant of Dearness Relief to State Government Pensioners.**

The Governor is pleased to order that the existing rate of Dearness Relief sanctioned vide Finance Department Order of even number dated 29-09-2010 to the State Government Pensioners who are in receipt of superannuation, retiring, invalid, compensation, family and extra ordinary pension etc. shall be revised from 45% to 51% with effect from 01-01-2011.

For the purpose of this order -


- (i) Pension/Family Pension in the case of pre-01.09.2006 retirees and where Family Pension was sanctioned prior to 01.09.2006, means the Consolidated Pension or Consolidated Family Pension, as the case may be, effective from 01.09.2006 in terms of Finance Department Memorandum No. F.12(3)FD(Rules)/2008 dated 12.09.2008.
- (ii) In the case of pensioners who retire from service on or after 01.09.2006 or where family pension is sanctioned for the first time on or after 01.09.2006, Pension/Family Pension means the Basic Pension/Basic Family Pension, as the case may be, in terms of Finance Department Notification No. F.12(3)FD(Rules)/2008 dated 12.09.2008.
- (iii) Dearness Relief will also be admissible on the additional quantum of pension / family pension allowed to the pensioners who have attained the age of 80 years and above.
- (iv) Payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- (v) Other provisions governing grant of dearness relief to pensioners' such as regulation of dearness relief during employment/re-employment, regulation of dearness relief where more than one pension is drawn etc., will remain unchanged.
- (vi) This order shall also be applicable in case of Pensioners/Family Pensioners who are in receipt of provisional pension.
- (vii) This order shall not be applicable in case of Old Age Pensions, Political Pensions or any other kind of similar pensions, which are not related to the service rendered under Government.
- (viii) Dearness Relief at revised rates as above would also be admissible to pensioners who retired/retire from service of

Panchayat Samiti or Zila Parishad and whose Pension Payment Orders have been issued by the Director, Local Fund Audit Department or Director, Pension and Pensioners' Welfare Department, Rajasthan, Jaipur.

The payment of arrear on account of the aforesaid revision in the rates of dearness relief for the period from 1-1-2011 to 31-3-2011 shall be made on or after 1-4-2011.
