B. Disease for treatment:


1. Heart Bypass-Surgery/Angioplasty / Angiography / Valve replacement and heart related operations.

C. Conditions :-

1. The amount to be reimbursed for above mentioned diseases, shall be restricted to the extent of the estimated amount indicated in the certificate to be issued by the Principal of Govt. Medical College / Director, Medical & Health Services for similar treatment taken at a Hospital in Rajasthan.
2. In case the treatment is not taken in a Govt. Hospital in the State of Rajasthan at the patient's choice, the reimbursable amount would be equivalent to expenditure admissible in the Govt. Hospital.
