ORDER-60

Sub:- Procedure of Direct Recruitment to the posts of Junior Engineer-I (Contract).

The Board of Directors in its 32nd Meeting held on 5th March, 2003 has accorded the approval for prescribing the procedure of direct recruitment to the post of Junior Engineer-I (Contract) on contract basis for an initial period of 2 years on contractual amount of Rs. 6500/- (Rs. Six Thousand Five Hundred) only per month as hereunder :-

- (1) Vacant posts of Junior Engineer -I (C) shall be filled in by Direct Recruitment from Open Market from candidates possessing Degree in Electrical, Mechanical, Electronics and Tele-communication (as the case may be) on contract basis for a period of two years on a fix contractual amount of Rs. 6500/- per month.

The bifurcation of vacant posts between different categories like Electrical, Mechanical, Electronics/Tele-communication etc. be decided at Company level later on.

- (2) A candidate applying for direct recruitment to the posts of Junior Engineer - I (C) must fulfil the following conditions :-

Qualification:

The candidate must hold a Degree in Engineering (Electrical/Mechanical/Electronics/Tele-Communication, as the case may be) of a University established by Law in India, or a Degree of a Foreign University or Institution, declared by the Competent Authority, equivalent to a Degree in Engineering (Electrical /Mechanical / Electronics / Tele-Communication, as the case may be) of a University established by Law in India.

Only those candidates, who possess minimum 60% marks in Engineering Degree in the respective discipline, shall be eligible for applying for appointment as JEN -I (C).

Provided that the other Backward Class candidates may be allowed relaxation of 5% marks and the SC / ST candidates may be allowed relaxation of 10% marks.

Age:

The candidate must have attained the age of 21 Years and must have not attained the age of 35 years on the first day of January 2003. The maximum age may be relaxed as per State Government's relevant provisions in this regard.


Inviting applications :

Applications shall be invited by advertising vacancies in two prominent daily Hindi News Papers of Rajasthan and one English New Paper of national level.

"Applications received shall be scrutinized and a merit list of eligible candidates, for each category, shall be prepared on the basis of marks obtained in the Degree in Engineering. Candidates, limited to two times of the vacancies, shall be called for verification of their testimonials and interview, by the Interview Committee, to be constituted by the Chairman & Managing Director. The selection shall be made by giving 80% weightage to the marks obtained in Engineering Degree and remaining 20% weightage to their performance in the interview."

The name of candidates considered suitable but not offered appointment, shall be kept in panel which shall remain in operation for next 4 months from the date of preparation of the list.
