ORDER-66

Sub:- Procedure of direct recruitment to the post of Junior Engineers-II (Contract) on contract basis

The Board of Director in its 37th meeting held on 12th June 2003 has accorded the approval for prescribing the procedure of direct recruitment to the post of Junior Engineer-II (Contract) on contract basis as hereunder:-

(a) Qualification:

The candidate must hold a Diploma in Engineering (Electrical / Mechanical / Electronics / Tele-Communication / Civil as the case may be) of a University / Poly Technic College / Institution established by Law in India, or a Diploma of a Foreign University / Poly Technic College or Institution, declared by the Competent Authority, equivalent to a Diploma in Engineering (Electrical / Mechanical / Electronics and Communication / Civil as the case may be) of a University established by Law in India.

Only those candidates, who possess minimum 60% marks in Engineering Diploma in the respective discipline, shall be eligible for applying for appointment as JEN-II (C). Provided that the Other Backward Class Candidates may be allowed relaxation of 5% marks and the SC /ST / Physically Handicapped candidates may be allowed relaxation of 10% marks.

(b) Age :

The candidates must have attained the age of 21 years and must have not exceeded the age of 35 years on the first day of January, next. The maximum, age may be relaxed as per State Government's relevant provisions in this regard.

(c) Reservation of Posts :

The reservation of posts for SC/ST/OBC/Physically Handicapped/ Women candidates will be as per State Government's relevant provisions in this regard.

(d) Inviting applications :

Applications be invited by advertising vacancies in two prominent daily Hindi News Papers of Rajasthan and One English News Paper of National Level.

(e) Scrutiny of Applications :

Application received shall be scrutinized and a merit list of eligible candidates, for each category shall be prepared on the basis of marks obtained in the Diploma Engineering.

(f) Recommendations of the Selection Committee :

Candidates, limited to three times of the vacancies, shall be called for interview and verification of their testimonials, by the Interview Committee, to be constituted by the Chairman & Managing Director.


The selection shall be made by giving 80% weightage to the marks obtained in Engineering Diploma and remaining 20% weightage to their performance in the Interview.

The list so prepared shall be placed before the CMD for approval and making appointment there from.

(g) Reserve List :


The name of candidates considered suitable but not offered appointment, shall be kept in panel which shall remain in operation for next four months from the date of preparation of the list. Further appointments shall be made from the panel in order of merit. After 4 months, the reserve list shall be ceased to be operative.

Further, the Board of Directors has also approved the ratio of 50% : 50 % to fill up the post of Junior Engineer-I (C) & Junior Engineer-II(C).
