Sub:-Amendment in AVVNL Services (Absorption of Ex-servicemen) Regulations, 2017.

In exercise of the powers conferred vide order No. AVVNL/CAO(R&C)/AAO(Rule)/F-15/OO/D.3416 dated 05.12.2011(AVVNL-Rule-527), the Managing Director, AVVNL is pleased to adopt the notification No. F.5(18)DOP/A-II/84 pt.IV dated 01.08.2021, issued by the Department of Personnel, GoR, regarding amendments in the RCS (Absorption of Ex-servicemen) Regulations, 1988.

Accordingly, the following amendments are hereby made in the AVVNL Services (Absorption of Ex-servicemen) Regulations, 2017:-

1. **Amendment in regulation 2:-** after the existing sub-regulation (4) of regulation 2 of the said regulations, the following new sub-regulation (5) shall be added, namely:-
"(5) Reservation to ex-servicemen will be admissible to only those who have settled in the State."
2. **Amendment in regulation 3:-** in clause (a) of regulation 3 of the said regulations:-
 - (i) for the existing expression " person who" the expression "person settled in the State and who" shall be substituted.
 - (ii) after the existing sub-clause (v), the following Explanation shall be added, namely:-
"**Explanation:** The expression 'person settled in the State' shall mean 'the person who is bonafide resident of the state'."

This order shall come in to force with effect from 01.07.2021


