ORDER - 98

Sub: Grant of Dearness Allowance to AVVNL Employees.

The Co-ordination Committee in its 68th meeting held on 24.3.2004 & the adjourned meeting held on 31. 3. 2004 & 1.4.2004 has decided to increase the rates of Dearness Allowance from 59% to 61% w.e.f. 1.1.2004 for the employees of Corporation.

The term 'Pay' for the purpose of calculation of dearness allowance shall be the pay as defined in Regulation 3 (xviii) , (a) of Employees Service Regulations 'drawn in the Revised Pay Scale prescribed vide erstwhile RSEB's Order No. RSEB/F&R/F.46(21) (iii)/D.11 dt. 24.2.1998, as amended from time to time, and shall not include any other type(s) of pay like special pay or personal pay, etc. In case of those employees who opt to retain the existing scale of pay, it will include, in addition to pay in the pre-revised scale, dearness allowance and interim relief appropriate to that pay admissible under orders in existence on 1.1.1996.

The payment on account of dearness allowance involving fraction of of 50, paise and above may be rounded of to the next higher rupees and the fractions of less than 50 paise may be ignored.

The amount of increased D.A. and its arrear will be paid as follows:-

1. The existing rate of dearness allowance may be increased from 59 % to 61%w.e.f 1.1.2004 and it shall be payable in cash w.e.f from on 1.7.2004.i.e salary for the month of June 2004 payable on 1.7.2004.
2. The amount of arrears of D.A. for the period from 1.1.2004 to 31.5.2004 will be paid in the following manner:-
 - a) In respect of employees drawing basis pay up to Rs. 10,500/- P.M. the arrears will be paid in cash in two(2) installments, as under:-


Period	To be Paid in
1.1.2004 to 31.3.2004	Aug 2004(After 15th)
1.4.2004 to 31.5.2004	Sep.2004(After 15th)

- b) In respect of employees drawing basic pay above Rs.10,500/- p.m. the arrears will be credited to their, GPF Account or invested in PPF/NSC as per authorisation in 2(two) installments as indicated at (a) above.

The payment of D.A. will also be subject to the terms and conditions laid-down in the Rules for drawal of DA given in Appendix XVI of the R. S. R. Vol. II.

The increased D.A shall also be admissible and paid in cash to those employees who were in service on or after 1.1.2004 but cease to be in services prior to the issue of this order, whether for disciplinary reasons or on account of resignation, retirement, death or discharge or -abolition of sanctioned post.
