
The provisions of this order shall also be applicable to the Pensioners of erstwhile RSEB.

**Subject :- Grant of Dearness Relief to State Government Pensioners.**

The revision of rate of Dearness Relief from 55% to 59% w.e.f. 1.7.2003 was sanctioned to the State Government Pensioners vide Finance Department Order of even number dated 6.10.2003. The cash payment of increase in dearness relief of aforesaid instalment has been allowed w.e.f. 1.3.2004 and in last para of the aforesaid order it was mentioned that order for payment of arrear for the period from 1.7.2003 to 29.2.2004 shall be issued separately in due course.
