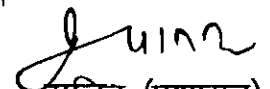

**GENERAL TERMS AND CONDITIONS OF TENDER AND
INSTRUCTION FOR FILLING OF TENDER**

1. Sealed tenders are invited for the supply of **Computer Paper Ream up to 2.30 P.M. of dated 4th September, 2018.**
2. The tender shall be submitted in the form attached herewith and all blank in the tender shall be duly filled in.
3. The tender and proof of depositing **Bid Security** shall be placed in separate cover and then shall be placed in Double Sealed Cover and clearly marked on the cover "**TENDER FOR THE SUPPLY OF COMPUTER PAPER REAM DUE ON 4th September, 2018.** Tender accompanied with all relevant documents should be addressed to the **Secretary (Admn), RRVPN Ltd, Vidyut Bhawan, Janpath, Jaipur.**
4. The tender in sealed cover, shall be delivered in the **Office of the Secretary (Admn), RRVPN Ltd, Vidyut Bhawan, Janpath, Jaipur** not later than 2.30 PM Indian standard time on dated **4th September, 2018.** Tender(s) shall not be accepted after the time and date fixed for receipt of the tender and will be returned unopened to the bidder. The tender will be opened by the Secretary (Admn). RVPN Ltd, Jaipur or the officer nominated by him at 3.00 pm on dated **4th September, 2018** in the presence of such bidders who wish to be present at the time of opening.
5. If the date fixed for receiving and opening of bidder is declared as public holiday, the tender shall be received and opened on the day on which office re-opens after such holiday(s) on the timing as indicated above.
6. The tender shall be signed by a responsible and authorized person. The name and authority of the signatory shall be stated clearly in tender. The tender should be only filled in with ink or typing form. No tender shall be filled in by pencil; otherwise, it shall be cancelled. All additions, alterations, cutting and over writings in tender must be clearly initialled by the signatory of the tender.
7. **The tender shall be valid for a minimum period of 90 days. Tender(s) mentioning shorter period than specified, is likely to be ignored.**
8. The bidder shall deposit the **Bid Security Rs 9,000/- (Rs. NINE THOUSAND ONLY)** to **SR. ACCOUNTS OFFICER (EA-CASH), RVPN, JAIPUR** either in cash or by crossed bank draft/Banker's cheque in the name of **SR. ACCOUNTS OFFICER (EA-CASH), RVPN, JAIPUR.** No other mode of deposit shall be accepted. Tender not accompanied by a copy of cash receipt of **Bid Security** / crossed bank draft/Banker's cheque shall be rejected. No interest shall be payable on such deposit (s).
9. Request for adjustment / proposals, for acceptance of **Bid Security** deposit, if any, already lying with the RRVPN in connection with some other tenders/orders shall not be entertained.
10. The Central / State Government's undertakings/corporations are exempted for furnishing of **Bid Security.** Other provisions related to deposit of **Bid Security** shall be applicable as per RTPP Act/Rules.
11. The **Bid Security** of unsuccessful Bidders shall be refunded soon after final acceptance of successful **Bid** and signing of agreement and submitting the **Performance Security.** In case of successful Bidder, the **Bid Security** will be refunded as per rules.

12. The RRVPN Ltd. reserve the rights to forfeit the **Bid Security** deposited or part thereof in circumstances which according to him indicate that the bidder is not interested in accepting / executing any order placed under the specification.
13. An amount equal to the 5% of contract value will be deposited by successful bidder as **performance security**. This amount will be refundable to the bidder after 60 days after final supply or completion of guaranty / warranty period or as decided by the Secretary (Admn), from the date on which the contract is finally fulfilled satisfactory.
14. The Secretary (Admn.) RRVPN Ltd., Jaipur does not bound himself to accept the lowest or any tender or any part of the tender and shall not assign any reason(s) for the rejection of the tender or part thereof.
15. Price shall be the criteria for selecting the lowest one bid. But quality shall also be checked while finalising the paper ream to be procured and if quality is found not up to the satisfactory level then better quality of paper ream may be selected at the discretion of the procuring committee.
16. The act of submission of tender to the Secretary (Admn.), RRVPN Ltd., Jaipur shall be deemed to constitute an agreement between the bidder and the Secretary (Admn) RRVPN Ltd., Jaipur, whereby such tender shall remain open for acceptance by the Secretary and bidder have no option to withdraw or impair or derogate his offer. If the bidder be notified during the period of validity of the tender that his tender is accepted by the Secretary (Admn), he shall be bound by the terms and agreement constituted by his tender and such acceptance thereof by the Secretary (Admn), until formal contract of the same has been executed between him and the Secretary (Admn) in replacement of such agreement.
17. The successful bidder have to execute an agreement on the non judicial stamp paper worth Rs 500/- (**Rs. Five hundred only**) or as applicable at the time for agreement, at his own cost, for satisfactory completion of order.
18. The prices quoted should be firm in all respect, inclusive of all levies, Freight packing, forwarding, insurance etc. and F.O.R. A.O. (Admn.-Store), RVPN, Vidyut Bhawan, Janpath, Jaipur.
19. The purchase authority reserves the right to increase/decrease the tendered quantity as per RTTP Act and Rules at the time of placement of order. Purchase Authority also reserves the right to drop the tender enquiry or to reduce the tendered quantity to any extent at its discretion.
20. The ordered material shall be supplied within 30 days positively from the date of issue of Purchase Order by this office.
21. The time and date of delivery specified above being the essence of the contract must adhered to and supply completed no later than the period specified in delivery clause. If the supplier fails to deliver the material as per order or any part thereof within the specified delivery period the purchaser shall have following option at his discretion:-

if the tender fails to supply the goods within the specified period or extended period, the purchase officer shall recover from the supplier @ ½ % (**half percent**) value of **the material** which the supplier has failed to deliver in time per week or part there of subject to a maximum of 10%

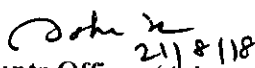

22. In case goods other than the approved quality, make, size etc. are supplied it shall be rejected and will have to be replaced within a reasonable time by the supplier without extra cost. The prices fixed by the purchasing officer shall be final and binding on the supplier.
23. The rejected articles must be removed by the bidder from the destination within 7 days from the date of information of rejection. The official concerned will take responsible care of such material but in no case shall be responsible for any loss shortage, damages that occur to it, in premises of contractor.
24. The contract of supply can be repudiated at any time if the supplies are not made to the satisfaction of the purchaser.
25. The payment will be made on presentation of bill in triplicate on completely execution of supply/work according to the order and specification. No payment of running bills or advance payment will be made.
26. The direct or indirect canvassing on the part of bidder or their representative will disqualify their tenders.
