


The rates as per this Circular are as follows :-

2. The POL & other consumables in Vehicle etc. will provided by the owner of the Vehicle.
3. The Salary of the Vehicle driver will be paid by the owner of the Vehicle (If vehicle is not driven by owner himself and driver is engaged)
4. All types of liabilities of the Vehicle will be borne by the Contractor/ Vehicle owner.
5. The rates/prices are firm inclusive of all taxes, duties, repairing & maintenance charges of vehicle, contribution of CPF/EPF & ESI & other liabilities except SGT, shall be paid extra by Nigam, if applicable on production of document.
6. Income tax & other taxes will be deducted at source as per Nigam rules.
7. All taxes except toll taxes will be borne by the individual/contractor/firm.
