2. **Bidder should be registered with GST act. The copy of GST Registration shall have to be uploaded in tendering.**
3. **The Bid Price shall be inclusive of all taxes except GST, which will be payable at applicable rate.**
4. No physical/ offline Tender/ bid shall be accepted.
5. The Bidder must have sufficient experience of execution of similar type of works in Govt. department / Public Enterprises.
6. The Tender cost & Earnest Money shall be in the form of Demand draft or Banker cheque of scheduled Bank drawn in favour of Accounts Officers (T&C), RRVPNL, Jodhpur payable at Jodhpur for works mentioned at S. No. 01 & 03, Accounts Officer (T&C), RRVPNL Bhadla payable at Phalodi for works mentioned at S. No. 04 to 04, Accounts Officer (T&C), RRVPNL Jaisalmer payable at Jaisalmer for works mentioned at S. 13. The bidder shall have to submit a certificate that he has an establishment covered under the provision of EPF Act, 1952 and having a separate registration with P.F. commissioners. In absence of the same, the contractor shall be liable to deposit employee's as well as employer's contribution (in respect of employees engaged by him for the said work) with RRVPNL, along with details of such employees and deduction as per RVPN CPF rules shall be made from his bills/ Security deposit.



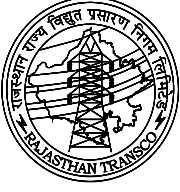

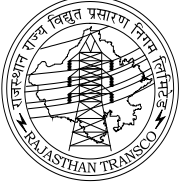
